

PUBLIC HEALTH, M.P.H. & MEDICINE, M.D. DUAL DEGREE

Saint Louis University's Master of Public Health/Medical Doctor dual degree program is conducted under the joint auspices of the College for Public Health and Social Justice and the School of Medicine.

The M.P.H. is offered as an accelerated program that can be completed in three consecutive semesters (summer, fall, spring) devoted entirely to M.P.H. coursework. The program requires completion of professional medical school requirements as well as the fulfillment of a complete M.P.H. with public health practice concentration (42 credits), which may include up to nine credits of coursework from the School of Medicine M.D. degree requirements.

Saint Louis University's College for Public Health and Social Justice is fully accredited by the Council on Education for Public Health (CEPH). The School of Medicine is accredited by the Liaison Committee for Medical Education (LCME).

Admission

Students must meet the admission requirements and be admitted into both degree programs according to the processes of each of the participating academic units in order to pursue a dual degree program.

Individuals may apply to the M.P.H. degree program concurrently with application to the School of Medicine or following their admission to the School of Medicine; however, admission to the dual degree program is contingent upon admission to both the M.P.H. and the M.D. degree programs.

Roadmap

Roadmaps are recommended semester-by-semester plans of study for programs and assume full-time enrollment unless otherwise noted.

Courses and milestones designated as critical (marked with !) must be completed in the semester listed to ensure a timely graduation. Transfer credit may change the roadmap.

This roadmap should not be used in the place of regular academic advising appointments. All students are encouraged to meet with their advisor/mentor each semester. Requirements, course availability and sequencing are subject to change.

Students complete the Doctor of Medicine curriculum then the M.P.H. curriculum.
